## 2011-2012 Graduate Plus Request Form

- You must file a 2011-12 year FAFSA and have applied for your annual maximum Federal Direct Subsidized and Unsubsidized loan eligibility before applying for the Graduate Plus Loan.
- You must enroll and stay enrolled at least six (6) credit hours per term in a graduate degree seeking program.
- Repayment begins within 60 days of the final disbursement. You may apply for deferment during the in-school period.
- You may apply for the difference between your cost of attendance less other financial aid. Refer to your award letter when deciding the amount you wish to borrow. The cost of attendance is listed on the back of your award letter.
- If you receive a graduate assistantship, that amount is considered a resource and is used in the formula to determine financial need. In order to remain compliant with federal regulations the amount of a graduate assistantship is subtracted from the cost of attendance to determine your remaining financial aid eligibility.
