F&A Costs are in addition to total direct costs. The MTDC (Modified Total Direct Cost) base includes all costs with the exception of: equipment greater than \$2,500 per unit, capital expenditures, patient care, tuition remission, off-site rental costs, scholarships, fellowships, and the portion of each subcontract in excess of \$25,000.

Recovered F&A Distribution:

PI - 5%; Dept - 15%; College - 10%; VP for Research & Grad Studies - 20%; University General Fund - 50%.

Fringe Benefit Rates

Fringe Benefit Rates differ based on source of funding (Federal or Non-Federal) and employee category.
