## 2014-2015 Graduate Plus Request Form

- You must file a 2014-2015 year FAFSA and have applied for your annual maximum Federal Unsubsidized loan eligibility before applying for the Graduate Plus Loan.
- You must enroll and stay enrolled at least six (6) credit hours per term in a graduate degree seeking program.
- Repayment begins within 60 days of the final disbursement. You may apply for deferment during the in-school period.
- You may apply for the difference between your cost of attendance less other financial aid. Refer to the net price calculator <http://www.csuohio.edu/enrollmentservices/netprice/index.html> when deciding the amount to borrow.
- If you receive a graduate assistantship, that amount is considered a resource and is used in the formula to determine financial need. In order to remain compliant with federal regulations the amount of a graduate assistantship is subtracted from the cost of attendance to determine your remaining financial aid eligibility.

*Before Graduate Plus loan funds can be disbursed, you must:*
