Financial Requirements for F-1 International Students

Financial documentation must be presented in order for Cleveland State University to issue a Form I-20 for your dependent family members. The amount you must demonstrate is over and above the amount of funds that you have shown for yourself.

Students with families should add the following amounts accordingly:

Spouse: \$3,500.00 **1st Child:** \$3,000.00 **2nd Child (and any subsequent children):** \$1,500.00

All financial documentation must be original and issued within the past year. The following documents are acceptable:

1. An original bank statement in your name, which indicates the amount of funds available.
2. An original bank statement in your guarantor's name (sponsor or parent) that indicates the amount available accompanied by a letter of confirmation from the guarantor of his or her intention to provide support. **The bank statement MUST indicate a minimum amount held in the account, on bank stationary with a telephone, FAX number, and street address.**
3. A letter of support from your government or other sponsoring agency that indicates the amount available.

If your documents indicate an amount in a currency other than U.S dollars we will convert the amount according to the exchange rate on the day we receive your financial support documents.

NOTE: A dependent child may not be older than 21 years of age.

U.S. born children who have a U.S. passport should NOT be issued Form I-20 as a family dependent.
