



## EDUCATION ABROAD

### Financial Policies

You are an accepted student to the CSU in England program. Upon signing this document, accepting your acceptance, you will be charged for the remainder of the program fee. Once you enroll in the required course through CampusNet, you will also be assessed the tuition fee for the required course. Please read below for detailed information regarding program costs and the refund/withdrawal policy. If you have any questions, please contact the Center for International Services and Programs.

### Program Fee

The program fee of \$2500 includes international airfare, breakfast, in country transportation, lodging, and a \$150 administrative fee. You have already paid \$250 toward the program fee. You will be charged the remainder of the program fee : \$2250. These charges will be assessed to your student account which you access through CampusNet. You will pay off your charges through your account, accessed through your individual CSU ID # and password. You will not make further payments into the England program budget. DO NOT recover the England budget account # from your application form. You no longer need the England account #, you only need your CampusNet account which will reflect the charge as follows:

### How to make a payment

You make payments toward these charges just like you would for tuition, electronically through Campusnet or by cash/check through the Cashier's Office (MC 115). You do not need any CSU account number except your own CSU ID to make the payment. If you have not paid the travel cost in full by Feb 13th, you may be removed from the program but will retain the full program fee. You may sign up for a budget payment for spring 2015 through CampusNet to make payments on the fee. Once enrolled in the BBP, please notify the Center for International Services and Programs. If enrolled in the BBP, the payment deadline of 2/13 no longer applies.

### Tuition

The cost of the required 3 credit course (MKT 440) or the 4 credit course (MKT 640) in spring 2015 is only added to your CSU student account when you have registered for the course; it is not included in the \$2500 travel cost. Please see the current tuition rates on the Office of Treasury Services website. If you are an undergraduate student and remaining within the tuition band for enrollments of 12-17 credits for the spring semester (with the additional of the 3 credit MKT 440) there should not be any additional tuition assessed.

## Use of Financial Aid

Students may use **spring financial aid** for this program. Please contact All-in-One Enrollment Services/Campus 411 to inquire.

## Out of pocket cost

Students will be responsible to pay out of pocket expenses, such as, but not limited to, some meals, independent sightseeing, private purchases, medical costs, and passport or visas costs. It is recommended that you budget about \$500 for onsite expenses such as meals.

## Refund/ Withdrawal Policy

Once accepted on a program, the non-refundable program deposit \$250 becomes forfeit; the student is considered financially and academically committed to this program once this signed Financial Policies statement is submitted. If a student has an extraordinary circumstance and needs to withdraw or is removed from the program after this Financial Policies statement has been agreed to with signature, an attempt at recovering any recoverable expenses will be made. However, the student remains responsible to pay CSU for any part of the program fee that is non-refundable or unrecoverable up to the full program cost.

Notification of withdrawal from the program must be made in writing to the program director and the Center for International Services and Programs.
