Eligible non-citizen.

Bring one of the following **ORIGINAL** documents to Campus 411, All-in-1

- Permanent Resident Card (I-551) – **Copy both sides of the document**
- Conditional Permanent Resident Card (I-551C) – **Copy both sides of the document**
- Arrival-Departure Record (I-94) *showing any one of the following designations:*
 - “Refugee”
 - “Asylum Granted”
 - “Parolee” (I-94 confirms that you were paroled for a minimum of one year and status has not expired)
 - “Cuban-Haitian Entrant.”
 - T-Visa holder (T-1, T-2, T-3, etc.)
 - valid certification or eligibility letter from the Department of Health and Human Services showing a designation of “Victim of human trafficking.”

NOTE: You are not eligible for financial aid if you are in the United States under one of the following designations:

- An F1 or F2 student visa,
- A J1 or J2 exchange visitor visa, or
- A G series visa (pertaining to international organizations)
- Deferred Action for Childhood Arrivals (DACA)
