Message from Chief Anthony Traska

It is a privilege to serve as Chief of Police for Cleveland State University, and I am pleased to present the 2019 Cleveland State University Campus Safety Annual Report which highlights the hard work, dedication, and commitment of our Campus Safety staff. The University Police Department, Access Control and Security Systems, and Environmental Health and Safety continue to work together as a single, cohesive team to ensure our campus is safe and equipped to handle unforeseen situations as they unfold.

Preparing the University to respond to critical incidents is a priority for the departments of Campus Safety. To be most effective, training and planning exercises must engage our entire campus community as well as law enforcement and Campus Safety personnel. We worked hard in 2019 to expand the number of emergency preparedness training classes throughout the year. This included additional ALiCE classes each month to provide greater opportunity for students, faculty, and staff to receive this valuable training. Additionally, a full-scale active threat exercise was conducted during the Spring semester to test the capabilities of our leadership teams across campus. Finally, we wrapped up our 2019 preparedness efforts with an intensive, three-day training course specifically designed for college campuses and their leadership teams. We look forward to continuing and building on these efforts with regular campus-wide drills and exercises in 2020.

The cornerstone of successful police-community relationships is the proactive maintenance of best practices in law enforcement standards. The University Police Department has maintained national law enforcement accreditation with the Commission on Accreditation for Law Enforcement Agencies (CALEA) since 2016. In addition, our police department is state certified with the Ohio Collaborative Community – Police Advisory Board. These certifications enhance and reinforce the University Police Department's commitment to professionalism while maintaining the highest standards among law enforcement agencies nationwide.



As part of our mission, we continue to be committed to providing opportunities to students to interact with our law enforcement officers through special programs including the FBI Academy, auxiliary police internships, and the CSO (Campus Safety Officer) student employment program.

It is an honor to work with the extremely professional and dedicated Campus Safety team of sworn, civilian, and student staff. These dedicated individuals are committed to the consistent delivery of reliable safety services to our campus community. The safety of our students, faculty, staff, and visitors to the CSU Campus remains our top priority.



Campus Safety Organization

The Division of Campus Safety is organized as three independent but interactive departments that report to the Chief of Police. This organization structure allows for quick response in decision making while maintaining efficiency and a single vision for operations and effectiveness.



Mission Statement

It is the mission of the Division of Campus Safety to support the University's academic, financial and community strategic initiatives, priorities and goals by maintaining a safe, peaceful, and orderly campus. In achieving this goal, it is the duty and responsibility of each member at all levels of employment within the department to consistently exhibit the highest standards of service, performance, and professionalism both internally and externally.

University Police

The Cleveland State University Police Department (CSUPD) is dedicated to protecting life and property, and detecting and preventing crime. The department includes sworn and non-sworn personnel, police, security, and student safety officers. CSUPD has received full accreditation status from The Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA).

CALEA was created in 1979 as a credentialing authority through the efforts of law enforcement's major executive associations: International Association of Chiefs of Police; National Organization of Black Law Enforcement Executives; National Sheriffs' Association; and the Police Executive Research Forum.

The accreditation program is designed to improve the delivery of public safety services, primarily by maintaining a body of standards, developed by public safety practitioners, covering a range of up-to-date public safety initiatives; establishing and administering an accreditation process; and recognizing professional excellence.

CSUPD is responsible for providing a safe and secure environment for the campus community. Officers patrol over 90 acres of state property in addition to surrounding city streets. The department operates 24 hours a day, 365 days a year and is comprised of the following units:

Patrol Division – The patrol division, is comprised of state certified police officers, security officers and student campus safety officers. Proactive patrols include all University owned buildings and grounds as well as city streets in and around campus.

Emergency Dispatch Center – The Emergency Dispatch Center directs all calls for service or emergency assistance as well as monitors fire and safety alarms.

Crime Prevention Unit – The Crime Prevention Unit participates in a range of educational outreach programs and presentations to heighten awareness and enhance safety on campus.

K-9 Unit – The K9 Unit is utilized for bomb detection through protective sweeps of events that occur on and off campus, checks of unattended packages and bags, and assistance to regional public safety agencies.

Detective Bureau – The Detective Bureau is tasked with investigative follow ups, background checks, security details, and fingerprint services.




Crime Prevention Unit

CSUPD's Crime Prevention Unit is committed to offering a wide range of comprehensive, proactive programs and procedures that anticipate, recognized and appraise crime risks and initiate actions to remove or reduce crime risks. Members of the Crime Prevention Unit work closely with groups and organizations on and off campus by initiating safety awareness programs and events. The Crime Prevention Unit has accomplished the following in 2019:

Canine Unit

CSUPD's Canine Unit consists of one law enforcement officer partnered with a highly-trained canine. The Canine Unit performs some of the same duties and tasks as standard police officers. They patrol the campus community to prevent and respond to crimes, perform investigations, locate and arrest perpetrators and detect dangerous explosives. The Canine Unit has accomplished the following in 2019:

Offices of Emergency Management and Environmental Health & Safety







The Offices of Emergency Management and Environmental Health & Safety help support the University's core missions of teaching, research, and service through emergency preparedness efforts and by promoting responsible environmental and occupational safety programs to protect the health and safety of students, faculty, staff and visitors while ensuring compliance with all federal, state, and local safety and environmental regulations. Access Control & Fire Safety & Security Systems Department







The Department of Access Control, Fire Safety & Security Systems (AC&SS) provides services to CSU campus community in the areas of integrated access control, closed-circuit television (CCTV), Emergency Notification Systems, Voice Emergency Notification Systems and Central Station Monitoring (fire, access, and duress) including the fire fiber loop and security support. Members of this team accomplished the follow successes in 2019:

- CIMP Building: Replaced four failed emergency phone cameras with new HD outdoor cameras.
 The new cameras use night vision on a schedule, and a double panoramic view to capture traffic
 in both directions. They cover the sidewalks on Euclid, E22nd, and common areas between IM
 building and Prospect.
- Euclid Commons 3: Installed new HD outdoor cameras with night vision on north and east side of building to address recent reported burglaries.
- Euclid Commons 4: Installed new HD Panoramic camera in common area between EC3/EC4, covering high traffic area and several doors. Uses panoramic views with night vision for 24/7 coverage.
- Parker Hannifin Building: Replaced a failed recorder, and brought fifteen cameras back online using a newer recorder from AC&SS inventory. Repaired failed rooftop PTZ camera.
- Berkman Hall & Business: Added electronic access control, intrusion systems directly linked to the police station, intercoms, emergency lockdown hardware, and other security upgrades to advising and Dean areas.
- Fenn Hall: Electronic access control to seven labs on the 3rd and 4th floors.
- Music & Communications: Electronic access to six rooms on the 4th floor.
- Washkewicz Hall: Phase 3 integration including intrusion and burglar alarms. Many rooms and labs
- Main Garage: Added camera coverage and electronic access control.
- Film School: 6th floor office space set up for Russo Brothers movie.
- Law Building: Re-coring of 44 cores and re-issuing 50 keys to faculty and staff.
- Total Work Orders: 1,548 work orders placed through the FAST service portal.
- Key Accountability: AC&SS has begun contacting separating employees and their direct supervisors with their Key Inventory and instructions for returns and transfers. Coupling this new process with the addition of Keybox usage has decreased the amount of key losses and security risks.
