### Financial Requirements for F-1 International Students

Financial documentation must be presented in order for Cleveland State University to issue a Form I-20 for your dependent family members. The amount you must demonstrate is over and above the amount of funds that you have shown for yourself. Students with families should add the following amounts accordingly:

- **Spouse:** \$3,500.00   **1<sup>st</sup> Child:** \$3,000.00   **2<sup>nd</sup> Child (and any subsequent children):** \$1,500.00
- **NOTE:** A dependent child may not be older than 21 years of age.
- *U.S. born children who have a U.S. passport should NOT be issued Form I-20 as a family dependent.*
