

## FACULTY/STAFF CROSS PARK DISABLED AUTHORIZATION FORM

**Form must be completed for each permit purchase**

Cross Parking Disabled Campus Authorization allows faculty and staff, with a prepaid permit and disability placard, to park in any green or white garages and lots. PayStation and metered garages/ lots are limited to designated prepaid/permit disabled spaces ONLY. Access to Prospect Garage must be coordinated with Parking Services; failure to coordinate may cause you to have to pay to exit the facility.

To access gated garages, permit holders MUST have their Viking Card to scan in and out. If you do not have your Viking Card, you cannot access a gated facility. Failure to scan in or out may cause you to have to pay to exit the facility. Permits are virtual; therefore, the vehicle's license plate must be registered to a valid permit and visible from the drive aisle while parked. Each individual who chooses to park at Cleveland State University agrees to comply with established rules and procedures. This access is granted for parking outside of purchased permit assigned areas for CSU work only and not for daily use. Your supervisor must grant this permission based on your job description and workload.
